- **Fiduciary & Ethical Duties:**
  - Act in good faith and with the level of care expected of a reasonable and prudent individual in a similar position.
  - Disclose any potential conflicts of interest and recuse yourself from discussions and decisions where conflicts arise.
  - Refrain from using the Board position for personal gain and maintain confidentiality of sensitive information.
- **Duty of Care & Loyalty:**
  - Engage actively in the decision-making process, applying sound judgment to fulfill the organization's best interests.
  - Prioritize the goals of SBC over any personal or external interests when making decisions on behalf of the organization.
- **Legal & Financial Accountability:**
  - Exercise diligence in all decisions, ensuring they are made for proper purposes, are free from material personal interest, and are backed by thorough information.
  - Assist with financial oversight of the Corporation.
- **Participation & Engagement:**
  - Regularly attend Board and pertinent meetings and come prepared to engage in discussions and decisions.
  - Remain informed about the organization's activities and review relevant documents, proposals, and information prior to making decisions.
  - Serve as a spokesperson alongside the other board members.
  - Guide the direction and performance of SBC, ensuring strong relationships among Board members and between the Board and stakeholders.
